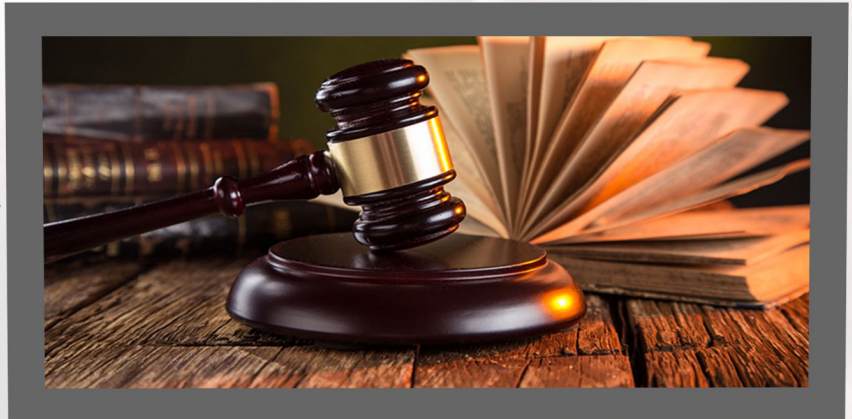

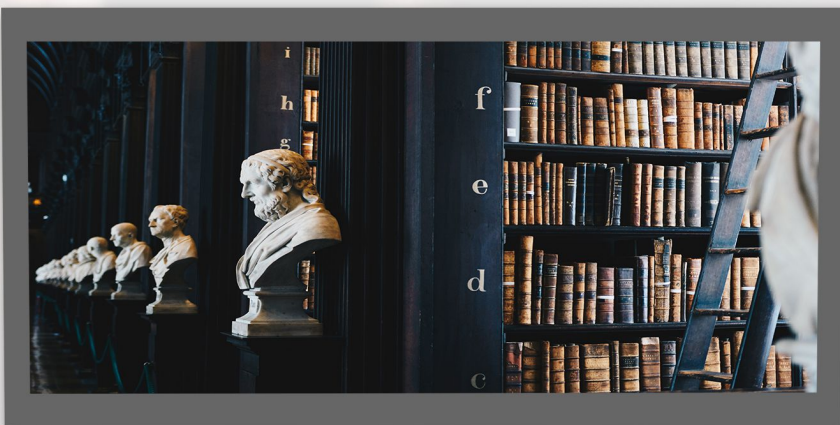

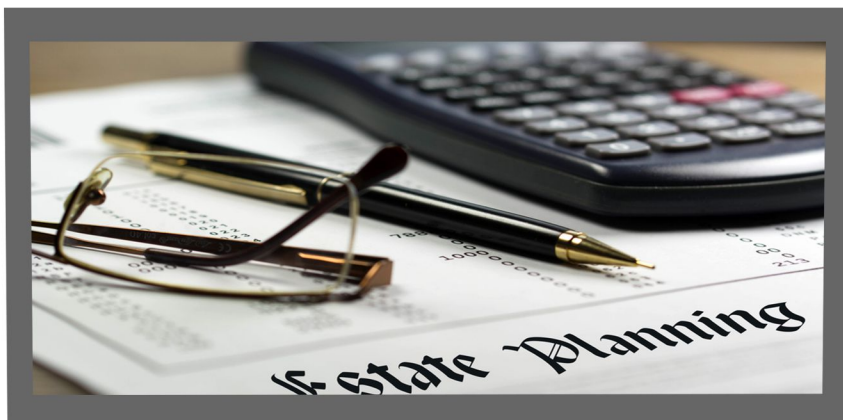
Divorce proceedings involve intense emotions and expenses. We will work with you throughout the divorce process to minimize the costs associated with the proceedings and the emotional strain.

FEES

During the initial consultation, we will determine the nature of your problem, see whether we can help you and, if so, at what cost.

We offer alternative billing arrangements such as agreeing on a fixed fee up front, that will give you peace of mind by assuring that you won't be met with unexpected legal fees. If you are happy to entrust us with your legal work, we will need you to supply us with certain information.

We require you to sign our engagement letter so that the scope of the work, the method of calculating the fee and the payment terms are in writing (for you to accept – in writing, an outline of the work to be done and a cost estimate notice in respect of the envisaged legal services). You are entitled to negotiate the proposed fees.

A retainer-based arrangement involves hiring us to provide agreed legal services at a specified monthly fee. The services are pre-established between you and our firm and are detailed in a retainer agreement. Generally, retainers exist for a specified length of time — 6 months or 1 year — and have a pre-determined fee, which is divided into consistent monthly payments and billed at the start of each month.

Advantages of retainer-based arrangements:

- You can budget for your legal fees and won't be billed per hour or per matter;
- You build a long-term relationship with our law firm;
- You have an outsourced law firm on your side, for much less than it would cost you to hire an in-house lawyer.
